


## Meeting of Appointment Committee of Civil Court, Sheikhpura Resolution


As per the direction of the Ld. District & Sessions Judge, Sheikhpura a meeting of the Appointment Committee, Civil Court Sheikhpura is held today i.e on 19.07.2017 at 5:15 P.M. with report to publication of the result of 36 successful candidates who have been selected according to merit in their respective category for appointment of the post of Peon/ Orderly in the Sheikhpura Judgeship and publication of 18 waitlisted candidates in case of non joining of any candidates from the selected list. The Committee resolved as under:-

1. The Hon'ble High Court has approved the selected list of 36 candidates for the aforesaid post vide letter no 40873/Admn(Misc.) Selection, dated 24.06.2017 and further approved the 18 waitlisted candidates vide letter no. 48086 File No. IV-181-2013/Admn.(Misc)Section dated 19.07.2017.
2. The Committee unanimously decided to publish the aforesaid result today on the website of the Civil Court Sheikhpura and on the notice board of the Civil Court Sheikhpura with name and roll no with category of the candidates.
3. It is further resolved that Administrative officer of the Civil Court Sheikhpura shall communicate the result and Appointment Letter to all selected candidates through letter individually with an intimation that they should join the service within 30 days from today i.e. the publication of the result on the website of the Civil Court, Sheikhpura.
4. The Committee has also resolved that selected candidates shall come to join in the Civil Court Sheikhpura with Original Documents along with two attested photographs and declaration of no Criminal case is pending against him and with the documents enumerated in the Appointment Letter.
5. It is also resolved that they should come to join the aforesaid post in white dress.
