Therefore, his promotion to the post of SDA on 12-5-1983 was without any Legal basis. Therefore, while refixing his seniorty, the official has to be reverted to the post of peon and kept in the Seniority List as at Sl.No. 17 for the year 1983 . Consequently, the official attains the eligibility for being promoted to the post of SDA on 28-5-1984 . Therefore, the official is deemed to be promoted in the cadre of SDA on 28-5-1984. Hence, his seniority in the cadre of SDA as on 28-5-1984 is at Sl. No.69.
