EXAMINATION FOR THE POST OF STENOGRAPHER GRADE-III**

- 1) Candidates should bring all necessary original certificates along with two sets (Attested Xerox copies) for verification.
- 2) The DEE sponsored candidates are directed to bring demand draft in favour of Prl. District and Sessions Judge, Mahabubnagar, for Rs.200/- on the date of examination along with photo attested by the gazetted officer in the Hall Ticket space provided.
- 3) The Candidates must bring their own Type writers for skill test.
- 4) If Original Hall Ticket is not reached in time, the candidate should bring the Hall Ticket down loaded from the website duly attested photo by the gazetted Officer by affixing the same on the said hall ticket.
- 5) Photographs are to be attested by the Gazetted Officer on the Hall Tickets within the space provided.
- 6) Candidates should sign on their hall tickets.
- 7) No TA and DA will be paid to the candidate for attending the exam.
- 8) Candidates should not carry any electronic devices such as Cell Phones, Electronic Calculators or electronic watch etc., into the exam hall.
- 9) Candidates arriving after the time mentioned on the call letter will not be permitted to enter the Examination hall.
